## **Map & Directions**

### **From the south:**

- From Highway 101, take the Carrillo exit;
- Turn right from the off-ramp onto Carrillo;
- At the fourth intersection, turn left onto Chapala;
- At the next intersection, turn right onto Figueroa, turn right;
- At the second intersection, turn right onto Anacapa;
- Stay in the right hand lane and take the third driveway in the middle of the block into Santa Barbara Public Parking Lot 8.

Our location is on the other side of the parking lot, directly across from the entrance (look for Brownstein sign on the building). The rate for parking is \$1.50 an hour after the first 75 minutes.

### **From the north:**

- From Highway 101, take the Carrillo exit;
- Turn left onto Carrillo;
- At the fourth intersection, turn left onto Chapala;
- At the next intersection, turn right onto Figueroa, turn right;
- At the second intersection, turn right onto Anacapa;
